


## Tanzania International Arbitration Centre

#### What is TIAC?

The Tanzania International Arbitration Centre (TIAC) is an institution established by Tanganyika Law Society, registered as a company limited by guarantee in November 2019, with the aim of promoting ADR by mobilizing its internal resources and mandated to facilitate the alternative resolution of disputes through domestic and international arbitration and mediation, ensuring competent and continued capacity building to ADR practitioners, the increased understanding of ADR by the private sector and increased awareness of Tanzania's ADR system. The establishment of a TIAC is geared towards building investor confidence in our jurisdiction's ability to rapidly and affordably resolve disputes, creating long-term employment opportunities and providing an alternative to litigation.





#### Who forms TIAC Membership?

TIAC membership is open and essential to accredited leading dispute resolution practitioners from all fields and sectors including law, engineering, finance, Information Technology and other disciplines

#### Why should you Join TIAC?

#### What are the needed qualifications for TIAC membership?

Recognizing that ADR practitioners are at different levels of development at any particular time, TIAC has devised its membership to recognize competency and the need for development at different levels and ensuring that its members gradual develop from one stage to higher stage. Thus, TIAC membership is categorized at Associate, Member and Fellow levels. Qualification to TIAC membership is detailed in the "TIAC Membership and Panels of Neutrals Appointment Regulations" as adopted by the TIAC Board of Directors in August 2021

# How much does it cost annually to subscribe for TIAC membership?

Annual Membership Fee are paid after approval of membership by the relevant TIAC authority as follows:

- 1.Annual subscription fee for the level of Associate shall be TZS 150,000/= for all disciplines of practice approved by the Centre
- 2.Annual subscription fee for the level of Member shall be TZS 250,000/= for all disciplines of practice approved by the Centre.
- 3.Annual subscription fee for the level of Fellow shall be TZS 350,000/= for all disciplines of practice approved by the Centre.
